- Additional documents: The invitation must be sent online by the inviting company via TAD (Trámites a Distancia) to the embassy or an original version of the invitation with notarization must be provided
- Additional documents 2: RENURE (Registro Nacional Unico de Requirentes de Extranjeros)

Submission procedure: The applicant must generally appear in person at the visa centre/embassy. The appointment is booked by us. The passport with the issued visa will be collected by us. Send us all documents following this checklist in advance by email for verfication.
