- Confirmation of employment stating the intention to resume work, with start working date required language: english
- Travel history of the previous 10 years (country, purpose of travel, dates of travel in Word or Excel format)
- Skill certificates
- Additional documents: If applicable evidence of change of name (marriage)

Submission procedure: The visa is an electronic visa. The issued visa will be sent to you in PDF form and should be carried with you when you enter the country. Send us all documents by email.
